BALMAS overview

The United Nations had recognized the transfer of harmful organisms and pathogens across natural barriers as one of the four greatest pressures to the world's oceans and seas, causing global environmental changes, and posing threat to human health, property and resources. Ballast water transfer by vessels was recognized as a prominent vector of such species, and was regulated by the International Convention for the Control and Management of Ship's Ballast Water and Sediments, 2004 (BWM Convention). The BWM Convention sets the global standards on ballast water management (BWM) requirements, while recognizing that regional and local specifics have to be considered for its effective implementation. The Adriatic Sea is a unique and highly sensitive ecosystem. The economic development and social existence of the coastal states strongly depend on the clean and preserved Adriatic Sea. However, the Adriatic Sea is also a seaway mainly used by international shipping transporting goods to or from Europe as hinterland, with also intense local shipping. Increasing, serious concern is the introduction of harmful aquatic organisms and pathogens (HAOP) by ships' ballast water. By developing a joint Adriatic Ballast Water Management Decision Support System, Ballast Water Management Plan and Strategy, BALMAS will ensure uniform BWM requirements to ease shipping and at the same time to maximize environmental and economic protection of all sea users. The general BALMAS objective is to establish a common cross-border system, which will link all researchers, experts and responsible national authorities from Adriatic countries in order to avoid unwanted risks to the environment from the transfer of HAOP. This can be achieved through control and management of ships' ballast waters and sediments. Further, long-term effective ballast water management (BWM) in the Adriatic will be set at the cross-border level utilizing this project's related knowledge and technology.

Executive summary

The BALMAS Project WP9 aims at drafting a BWM Strategy for the Adriatic region, including key elements to address the long-term regional implementation of the BWM system developed by the project (including the BWP Plan and the BALMAS DSS). Both the BWM system and the Strategy will facilitate the Adriatic Sea bordering Countries to comply with the legal obligations deriving from the International Convention for the Control and Management of Ships' Ballast Water and Sediments signed in London in 2004 once it will enter into force. Whilst the Strategy is not intended to fix priorities, which remain in the sole Governments responsibility, it will put forward a common context and horizon, supporting the further development of a co-ordinated cross-border implementation of BWM in the region.

To this end, through WP9 Activity 1 an analysis of the legal and policy instruments existing at international, EU, regional and national levels is being carried out. Furthermore, Activity 2 of WP9 is specifically devoted to the assessment of the institutional sustainability of the BWM in the Adriatic Sea bordering Countries, taking into account the need of a co-ordinated approach between them. Such analysis should lead to anticipate, to the possible extent, the institutional efforts needed to carry out in the long term an effective

and coordinated implementation of the BWM system in the Adriatic. This also involves the relations between stakeholders that could be potentially relevant at national level for the implementation of the legal obligations deriving from the BWM International Convention. In this perspective, first Activity 9.2 planned output was the drafting of a list of main authorities and other stakeholders including, where available, their contacts, which is delivered through this report. In drafting the list, the preliminary findings of the legal analysis carried out under activity 9.1. have been taken into account, leading to group stakeholders by those sectors considered potentially relevant (i.e. Shipping/maritime transport, Ports, Environmental protection, Research, Fishery, Tourism, Health, Multiple, Other). The list enclosed herewith will help to drawing up recommendations for a long-term institutional sustainability of BWM in the Adriatic and, where appropriate, to organize specific meetings in BALMAS partners Countries to complete or clarify the information gathered. The list will be slightly changed and updated when disseminated as an attachment to the “Final Report on legal and policy instruments relevant for the BWM Plan and its implementation in the Adriatic region”, which is expected to be delivered as a public document in December 2015.

Introduction: objectives and methodology followed in drafting the Contact list of authorities, public bodies and other stakeholders relevant for the ballast water management in the BALMAS partners Countries

The legal, policy and institutional context of the Countries bordering the Adriatic Sea as well as means available for their cooperation was considered as an essential background of the BALMAS Strategy supporting the implementation of the Ballast Water Management system. In particular, within the projects' WP9, Activity 2 was specifically devoted to the evaluation of the institutional sustainability of the BWM system in the BALMAS partners Countries. The evaluation will provide a better understanding of what is needed to properly manage - both at national and regional levels - the harmful effects of ballast water discharges from ships in the Adriatic sea basin (i.e. who can be involved, tasks to be performed, adequacy of available means, etc.). In this perspective, a comprehensive picture of the whole range of implications connected to the Ballast Water Management in the Adriatic area was also needed. And even if, due to the relevance of the International Convention for the Control and Management of Ships' Ballast Water and Sediments (BWM), the shipping sector, both public and private, should appear at a first glance as the only relevant, this assumption is less certain when going deeper into the matter.

In fact, it is important to consider that once the legal obligations deriving from the BWM International Convention will enter into force, they should be implemented through the existing framework of legal obligations and public competences. A deeper knowledge of this framework and of its interconnections with other interests, obligations and stakeholders could therefore facilitate the smoothest implementation of the Convention rules. Ports organization, environmental standards, health protection, research advancements, tourism development and fishery activities can interfere with the global standards implementation (i.e. harmful pathogens can originate health warnings, algal blooms can damage tourism economies, invasive species can create problems to fisheries, etc.). Furthermore, it is worth underlining that in the Adriatic Sea basin, due to the proximity of the coastal areas of riparian Countries, activities carried out under the jurisdiction of one State are likely to have consequences on other States.

Along these considerations, the effective and coordinated implementation of the BWM system in the Adriatic Sea requires an institutional analysis able to consider multiple aspects. As a starting point, the BALMAS project planned an identification of the relevant authorities as well as of other bodies and/or stakeholders that - in different ways, at different levels and with different responsibilities - could have a role in dealing with the BWM. The *Contact list of authorities and main stakeholders relevant for the ballast water management in the Adriatic sea* was conceived for multiple purposes: e.g. as a tool for identifying the main differences between public structures of bordering States, as a map supporting the authorities when implementing the BWM legal obligations, as a basis to develop further work, drawing conclusions on what is already available and identifying room for improvements where needed.

In drafting the list, the preliminary findings of the legal analysis carried out under Project Activity 9.1. have been taken into account. Accordingly, the authorities, public bodies and other

stakeholders identified were grouped by sectors considered potentially relevant (e.g. Ports, Shipping and Maritime Transport, Environmental Protection, Research, Fishery, Tourism, Health Protection, Foreign Affairs, Multiple, Other).

In order to avoid duplication of efforts within the project, the information on stakeholders initially gathered for the BALMAS *Communication and Dissemination Plan* was taken as a starting point for the national screening. On this basis, additional work was required in order to identify those bodies and organisms which could emerge as relevant when focusing on the broader policy implications of ships' ballast water and sediments management. To this end, the contribution from WP9 contact persons as identified by one project partner per Country was essential and guaranteed the sharing of the list at national level.

For each Country, the contact list is made of two parts. The first part concerns the public sector – namely authorities and other public bodies, national and local - and the second one is related to private interest organizations.

As far as the public sector is concerned, the list focuses on those entities entrusted with public functions and duties in sectors more directly connected to the management of ballast water i.e. shipping and maritime transportation, ports management and port state control, shipping safety and ships pollution prevention. Authorities and bodies carrying out broader environmental and biodiversity protection tasks were also included as well as fishery and health authorities. At the local level, regional or municipal bodies, depending on the peculiarities of each Country, were taken into account.

As far as the category "Other stakeholders" is concerned, it includes organizations that could be affected by the implementation of BWM international rules and standards: i.e. those organized professionals operating in the shipping or shipbuilding sector, NGOs working in the field of the protection of the marine environment, fisheries and aquaculture organizations, private research entities, professional associations dealing with marine tourism.

The Contact list goes beyond the names of the institutions and includes available information on specific structures or offices, contact persons or web sites. Up to now, for reasons of privacy the list is an internal document; it will be slightly changed (and updated) once it will be attached to the "Final Report on legal and policy instruments relevant for the BWM Plan and its implementation in the Adriatic region" which is foreseen as a public document to be delivered in December 2015.
